**BY-LAW NO. 2009-064**

**BEING A BY-LAW TO AMEND BY-LAW 2001-030, A BY-LAW TO REGULATE  
THE COLLECTION, REMOVAL AND DISPOSAL OF WASTE IN THE  
TOWNSHIP OF SMITH-ENNISMORE-LAKEFIELD**

**WHEREAS** the Ontario Municipal Act, 2001, S.O. 2001, c. 25, Section 2, as amended, states that municipalities are created by the Province of Ontario to be responsible and accountable governments with respect to matters within their jurisdiction, and as such, municipalities are given powers and duties under this Act, and many other Acts, for the purpose of providing good government with respect to those matters;

**AND WHEREAS** the Ontario Municipal Act, 2001, S.O. 2001, c. 25, Section 5.3, as amended, states that a municipal power shall be exercised by By-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** the Council of the Township of Smith-Ennismore-Lakefield deems it necessary to amend By-law 2001-030, to allow the dumping of tires at no charge;

**NOW THEREFORE** the Council of the Corporation of the Township of Smith-Ennismore-Lakefield **ENACTS AS FOLLOWS:**

1. That Schedule "A" of Bylaw 2001-030 that establishes a Schedule of Fees for the By-law that regulates the collection, removal and disposal of waste be deleted in its entirety and replaced with the following Schedule "A":

Garbage weighing less than 14kg.	\$ 1.00 each
Loose Garbage, Non Recyclable Rubbish and Passenger Tires	\$ 95.00 per tonne
Major Appliances & Large Household Furnishings	\$ 95.00 per tonne
Compactor Garbage or Non Recyclable Rubbish	\$ 95.00 per tonne
Construction Debris	\$ 95.00 per tonne
Brush, Woodchips and Clean Lumber	\$ 40.00 per tonne

<u>BAG TAGS</u>	<u>RATE</u>
Bag Tag issued by the Municipality	\$ 2.00 each

**APPLIANCES/ITEMS CONTAINING FREON**


Appliance or items containing freon	\$ 10.00 each **

2. That By-law 2007-110 be repealed in its entirety.
3. That all other provisions of By-law 2001-030 remain in full force and effect.
4. That this By-law shall come into full force and effect on September 1, 2009.
