

**THE CORPORATION OF THE
TOWNSHIP OF SMITH-ENNISMORE-LAKEFIELD**

BYLAW NO. 2001- 36

**BEING A BYLAW TO AMEND BYLAW 2001-30 TO PROVIDE FOR THE
COLLECTION, REMOVAL, AND DISPOSAL OF GARBAGE AND OTHER
WASTE MATERIAL FOR THE TOWNSHIP OF SMITH-ENNISMORE-
LAKEFIELD PURSUANT TO THE MUNICIPAL ACT RSO 1990, CHAPTER
M.45, AND SECTION 208**

WHEREAS The Municipal Act RSO 1990, Chapter M.45, Section 208.2 and 208.3 states that the Council of a local municipality may pass Bylaws to establish, maintain and operate a waste management system including the collection, removal and disposal of garbage or other refuse and for contracting with any person for this purpose;

AND WHEREAS the Municipal Act RSO 1990, Chapter M.45, Section 208.6(2)(a) permits the municipality to, in a Bylaw enacted under Section 208.2, require the separation of any class of waste at the point of collection;

AND WHEREAS the Township of Smith-Ennismore-Lakefield deemed it advisable to pass Bylaw 2001-30 to provide for the collection, removal, and disposal of garbage and other waste material for the Township of Smith-Ennismore-Lakefield pursuant to the Municipal Act RSO 1990, Chapter M.45, and Section 208 and to repeal Bylaws 97-17 and 96-89 of the former Village of Lakefield and to repeal Bylaw 1998-20 of the former Township of Smith-Ennismore.

NOW THEREFORE the Council of the Corporation of the Township of Smith-Ennismore-Lakefield **ENACTS AS FOLLOWS:**

1. That Bylaw 2001-30 with respect to the provision for the collection, removal, and disposal of garbage and other waste material for the Township of Smith-Ennismore-Lakefield pursuant to the Municipal Act RSO 1990, Chapter M.45, and Section 208 is hereby amended by deleting section 8.(1) and inserting in its place and stead:

SECTION 8.0

- 8.1 That Bylaws 97-17 and 96-89 of the former Village of Lakefield and Bylaw 1998-20 of the former Township of Smith-Ennismore are hereby repealed in their entirety. The Township of Douro Dummer Bylaw 1998-55, as amended, as it relates to the annexed area described in Schedule A of the Ministers orders dated February 10, 2000, is hereby repealed.
