BY-LAW NO. 2007- 110

**BEING A BY-LAW TO AMEND BY-LAW 2001-30, A BY-LAW TO REGULATE
THE COLLECTION, REMOVAL AND DISPOSAL OF WASTE IN THE
TOWNSHIP OF SMITH-ENNISMORE-LAKEFIELD**

WHEREAS Section 11, of the Municipal Act, 2001, S.O. 2001, C. 25, as amended, states that a municipality may pass By-laws respecting matters within certain spheres of jurisdiction including waste management;

AND WHEREAS the Council of the Township of Smith-Ennismore-Lakefield deemed it necessary to pass By-law 2001-30 to regulate the collection, removal and disposal of waste in the Township of Smith-Ennismore-Lakefield;

AND WHEREAS By-law 2005-42 was passed on April 26, 2007 to establish fees for the disposal of brush and woodchips and it is now deemed advisable to repeal By-law 2005-42 in its entirety;

AND WHEREAS the Council of the Township of Smith-Ennismore-Lakefield deems it necessary to amend By-law 2001-30, to establish a new schedule of fees at the Smith Landfill Site;

NOW THEREFORE the Council of the Corporation of the Township of Smith-Ennismore-Lakefield **ENACTS AS FOLLOWS:**

1. That Schedule "A" of Bylaw 2001-30 that establishes a Schedule of Fees for the By-law that regulates the collection, removal and disposal of waste be deleted in its entirety and replaced with the following Schedule "A":

SCHEDULE OF FEES**

TIPPING FEES

<u>VOLUME OR TYPE</u>	<u>RATE</u>
Garbage weighing less than 14kg.	\$ 1.00 each
Loose Garbage, Non Recyclable Rubbish and Passenger Tires	\$ 95.00 per tonne
Major Appliances & Large Household Furnishings	\$ 95.00 per tonne
Compactor Garbage or Non Recyclable Rubbish	\$ 95.00 per tonne

RATE

Bag Tag issued by the Municipality \$ 2.00 each

APPLIANCES/ITEMS CONTAINING FREON

Appliance or items containing freon \$ 10.00 each **


*** Note: This fee is in addition to the applicable tipping fee as set out above.*

2. That By-law 2005-42 be repealed in its entirety.
3. That all other provisions of By-law 2001-30 remain in full force and effect.
4. That this By-law shall come into full force and effect on January 1, 2008.
